

ORDINANCE NO. 1607

AN ORDINANCE AMENDING CHAPTER I, ARTICLE 2, SECTION 1-203, CODE OF THE CITY OF COLBY, KANSAS, 2017, TO RESCHEDULE THE GOVERNING BODY'S SECOND REGULAR MEETING FOR THE MONTHS OF FEBRUARY THROUGH AND INCLUDING NOVEMBER, 2019.

WHEREAS, Chapter I, Article 2, Section 1-203 of the Code of the City of Colby, Kansas, 2017, now provides for regular meetings of the governing body to be held on the first and third Tuesday of each month at 5:30 PM; and

WHEREAS, the Governing Body finds it to be in the best interests of the Governing Body and the City Manager to provide an opportunity for the City Manager to participate in continuing professional development which will conflict with some of the regularly scheduled meetings for the calendar year 2019; and

WHEREAS, in order to be certain the City Manager is available to be present at meetings of the Governing Body, the Governing Body wishes to amend Chapter I, Article 2, Section 1-203 in order that the regular meeting of the Governing Body now scheduled for the third Tuesday of each month at 5:30 PM, be scheduled for the third Monday of each month for the months of February, March, April, May, June, July, August, September, October, and November of 2019 only.

THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS:

SECTION 1. Chapter I, Article 2, Section 1-203 of the Code of the City of Colby, Kansas, 2017, is amended and modified for the calendar year 2019 only, by scheduling the second regular monthly meeting of the Governing Body for the third Monday of the months of February, March, April, May, June, July, August, September, October, and November of 2019.

SECTION 2. Except as expressly provided above, all meetings of the Governing Body of the City of Colby, Kansas shall be convened on those days and times as presently set forth in Chapter I, Article 2, Section 1-203 of the Code of the City of Colby, Kansas, 2017.

SECTION 3. in the event a regular meeting or a rescheduled meeting as provided by this Amendment shall fall on any legal holiday or any day observed as a holiday by the City offices, the Governing Body shall fix the succeeding day not observed as a holiday as a meeting day.

SECTION 4. Except as expressly provided by this Amendment, Chapter I, Article 2, Section 1-203 of the Code of City of Colby, Kansas, 2017, is ratified and affirmed.

SECTION 5. This ordinance shall be in full force and effect from and after its publication in the official city papers provided by law.
