

ORDINANCE NO. 1680

AN ORDINANCE AMENDING THE CODE OF THE CITY OF COLBY, KANSAS, 2017 CHAPTER 1, ARTICLE §1-508: CITY ATTORNEY; OFFICE; DUTIES; COMPENSATION: DESIGNATING TERM OF OFFICE, COMPENSATION, QUALIFICATIONS, AND DUTIES OF THE CITY ATTORNEY OF THE CITY OF COLBY, KANSAS, AS AUTHORIZED BY K.S.A. 14-201 AND 14-205; REPEALING ORDINANCE NO. 1661 DATED DECEMBER 5, 2023.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS:

SECTION 1. The Code of The City of Colby, Kansas, 2017, Chapter 1, Article §1-508 City Attorney; Office; Duties; Compensation. is hereby amended as follows:

§ 1-508 CITY ATTORNEY; OFFICE; DUTIES; COMPENSATION.

(a) *Appointment and term of office.* The City Attorney shall be appointed by the Mayor, by and with the consent of the Council, for a term of one year, the term beginning each year on January 1, and until a successor is appointed and qualified;

(b) *Eligibility.* No person shall be eligible for the office of City Attorney who is not by profession an attorney-at-law admitted to practice in the Supreme Court of Kansas;

(c) *Qualifications.* The City Attorney shall be a qualified elector of the county;

(d) *Compensation.* The compensation of the City Attorney for the 2025 term is \$250 per hour, paid membership for the Kansas City Attorneys' Association, and reimbursement for registration fee, mileage and lodging to attend the annual meeting.

(e) *Job description.* The duties and responsibilities of the City Attorney within the monthly salary shall be as follows.

I. The City Attorney shall represent the City of Colby and shall perform all duties required of city attorneys of a city of the second class within the State of Kansas as required by the laws of the State of Kansas; and, further, all duties as required by ordinances passed by the City of Colby, Kansas; provided, however, that the City Attorney position is not a full-time employee of the City of Colby and shall not be entitled to benefits accorded to the City employees. The City Attorney's duties shall include the following, to-wit:

- (A) Enforce the City of Colby Municipal Code and prosecute related offenses and violations of the city ordinances as authorized by the City Manager;
- (B) Give legal advice to city officials, Police and Fire Department employees and other city employees as authorized by the City Manager;
- (C) Prepare certain legal papers and documents as required which may include preparation of certain ordinances and resolutions; and

(D) Attend all regular Council meetings as requested; and, upon request, special Council meetings or board meetings as advisor.

II. Representation, not included in normal service as above described, shall be authorized by the governing body of the City of Colby, Kansas. This representation is not part of the City Attorney's normal duties and shall be billed at an hourly rate approved by the Governing Body. Such representation may include bond issues, litigation, condemnation proceedings, jury trials above the Municipal Court level and out-of-city legal services on behalf of the City of Colby.

III. The City Attorney shall furnish a monthly accounting of the service provided under the monthly retainer and billed as additional representation.

IV. The City Attorney may assign various legal duties to other licensed attorneys in the City Attorney's office and with the City Attorney's supervision.

Private practice. Nothing herein shall prevent or limit the City Attorney from conducting his or her private practice or prevent the city from obtaining other counsel to represent it on specific matters or cases not included under the duties of the City Attorney.

SECTION 2. REPEALER. Ordinance No. 1661, dated December 5, 2023, is hereby repealed.

SECTION 3. The Code of The City of Colby, Kansas, 2017, Chapter 1, Article §1-508 City Attorney; Office; Duties; Compensation is here by amended.

SECTION 4. This Ordinance shall be in full force and effect from and after its publication in the official city paper as provided by law.
